

Attestation Disclaimer

- 1. I declare that the information provided by me for the purpose of preparing my Will is true and accurate to the best of my knowledge. I acknowledge that GM Legacy shall not be held liable for any errors or consequences arising from any incorrect or incomplete information furnished by me.
- 2. This Will reflects my final intentions, and I accept that this signed Will **supersedes all prior drafts**.
- 3. I agree that there will only be one signed, latest and original Will.
- 4. I shall sign the Will in the presence of **two witnesses**, both at least 21 years old and of sound mind; the two witnesses need not know the Will's content but are aware that I have read and understood the Will's content. **Neither the witness nor the witness' spouse is a beneficiary** and both witnesses shall sign in my presence to signify that they witnessed my signing.
- 5. I will safe-keep my signed Will unless stated otherwise, and GM Legacy is not liable for any damaged or missing Will.
- 6. I accept that my **movable assets may be subject to the laws of my domicile country**, which may entail any possible forced heirship, Faraid, inheritance & estate taxes, and other estate matters.
- 7. I accept that my **immovable assets are subject to the laws of the country in which they are situated**.
- 8. I understand and acknowledge that if my Will covers **assets in more than one jurisdiction**, my executor(s) may have to reseal or **obtain a fresh Grant of Probate** in other jurisdictions where I have assets.
- 9. I understand and I will seek independent legal advice and verify with the relevant authorities or professionals in the respective jurisdictions to determine the applicability of this Will.
- 10. I understand and acknowledge that if I did not specify any substitute beneficiaries under the residuary estate, there would be consequences if the main beneficiary predeceases me.
- 11. I understand and acknowledge that if I do not specify any substitute executor, there will be consequences if the main executor predeceases me or cannot act for whatever reason.
- 12. If applicable, I understand that any message included in this Will to my loved ones does not carry any legal weight or obligation on my executor and trustee; and it does not affect the distribution of my estate.
- 13. I do not suffer from any mental condition that could negatively influence me or am not subject to undue influence to make gifts in the Will.
- 14. I acknowledge that GM Legacy will not be held liable if the Will is not finalised by me and my two witnesses.
- 15. I acknowledge that I am responsible for finding two witnesses and reviewing the Will before signing.
- 16. I acknowledge that I will sign the Will first, followed by my two witnesses, during the will signing. The Will signing is to be completed in the same setting by me and my two witnesses (**No digital signature**).



- 17. If I appoint Precepts Trustee Ltd (PTL) as either the primary or substitute executor and trustee, PTL requires a scanned copy of the signed Will, Attestation Form, Executor Appointment Form and copy of ID to be submitted to Precepts office at 10 Anson Road, #06-17, International Plaza, Singapore 079903 or via email to GMLexecutorship@preceptsgroup.com.
- 18. If I appoint the Trust company as Sole or Substitute Executor &/or Trustee in my Will, it shall be remunerated in accordance with the **prevailing Schedule of Fees** current at my death as varied from time to time during the administration of my estate or any trust arising under the Will. The Trust company shall be entitled to deduct from the funds of the estate and/or trust, its fees and disbursements.
- 19. I understand that if I do not send the scanned copy of the signed Will, Attestation Form, Executor Appointment Form and copy of ID to PTL, PTL reserves the right to not accept the appointment of PTL as your executor and trustee.
- 20. It is my responsibility to ensure that my family members or other persons inform the Trust Company of my demise through a certified copy of the Death Certificate. The Trust Company shall not be responsible for any delays in the performance of its duties if a certified copy of the Death Certificate is not provided to the Trust Company.
- 21.
