I hereby agree to the following Terms and Conditions for the National Will Custody Services provided by **Precepts Legacy Pte. Ltd. (the 'Company')** for my Will dated _____.

- 1) The National Will Custody Services provided by the Company is for the keeping of my Will only. The size of my Will shall not exceed the size of A4 paper.
- 2) The Company shall not be responsible for the validity of my Will. The Company do not acknowledge or accept any item placed in the custody is genuine, original or belongs to me. The Company is not obliged to ensure that my Will kept in the National Will Custody is my latest Will.
- 3) I agree and accept that it is my responsibility to inform the Company promptly in writing of all changes to my address and contact details.
- 4) An authorised officer of the Company shall reserve the right to verify the document received from me so as to confirm my Will is dated as mentioned above.
- 5) The Company agrees to keep a copy of the sealed Personal Asset Inventory Booklet (PAIB) provided by the Company together with my Will. The Company is not obliged to keep any other documents other than the sealed PAIB. I understand that the storage of PAIB is free of charge if I subscribe for National Lifetime Custody or S\$54.50 (inclusive of 9% GST) per deposit if I subscribe for National Annual Custody.
- 6) In the event of death, the Company reserves the right to verify the identity of my executor(s) from my Will in order to release my Will to the said executor(s). The Company shall only release my Will to any beneficiary named in my Will upon my death, in the event all the executor(s) named in my Will is/are proven to have predeceased me or is/are unwilling or unable to act for whatsoever reason. The Company shall have the absolute discretion as to which beneficiary to release my Will to.
- 7) I or my executor(s) or administrator(s) hereby agree that until the Company received notice of my death, my estate shall continue to be liable for any outstanding custody fees payable to the Company until my legal representative discontinues my custody service with the Company notwithstanding the grant of representation has yet to be obtained from the Court.
- 8) Custody type:
 - I will pay the **National Annual Custody** fee of S\$163.50 (inclusive of 9% GST) within 30 days from the renewal date as stated in the renewal notice or such fee as may be revised by the Company from time to time on being notified by the Company.
 - I will pay S\$1,308.00 (inclusive of 9% GST) for the **National Lifetime Custody** fee.
 - I will keep my Will under my existing ***National Annual Custody/National Lifetime Custody** with the Company.

- 10) I acknowledge that once I discontinue the National Custody Will Services (either National Annual Custody or National Lifetime Custody) and retrieved my Will from the Company, there shall be no refund of any part of or pro-rated option of the custody fees from the amount I have paid.
- 11) The Company reserves the right to change the Terms and Conditions at any time without prior notice.
- 12) I consent, either through the ESP or by myself, to disclosing to the Company any and all personal data that the Company considers is reasonably necessary or desirable to enable the Company to provide the services contemplated by this document.

I also agree that my personal data might be stored in jurisdictions other than Singapore as the Company adopts cloud-based solutions for client administration of the Company and the Company has provided a summary of the extent to which my personal data will be protected to a standard comparable to that under the PDPA, in the jurisdictions that it will be transferred to, in the data protection policy of the Company.
